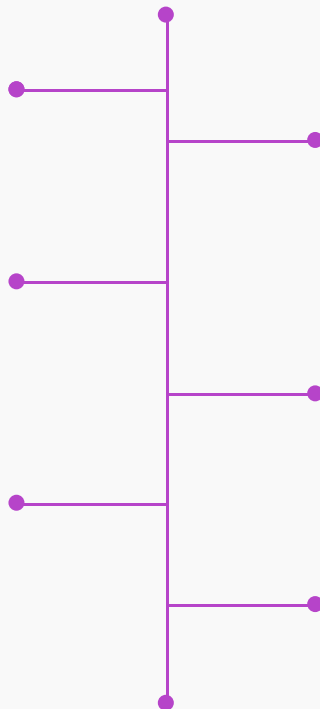

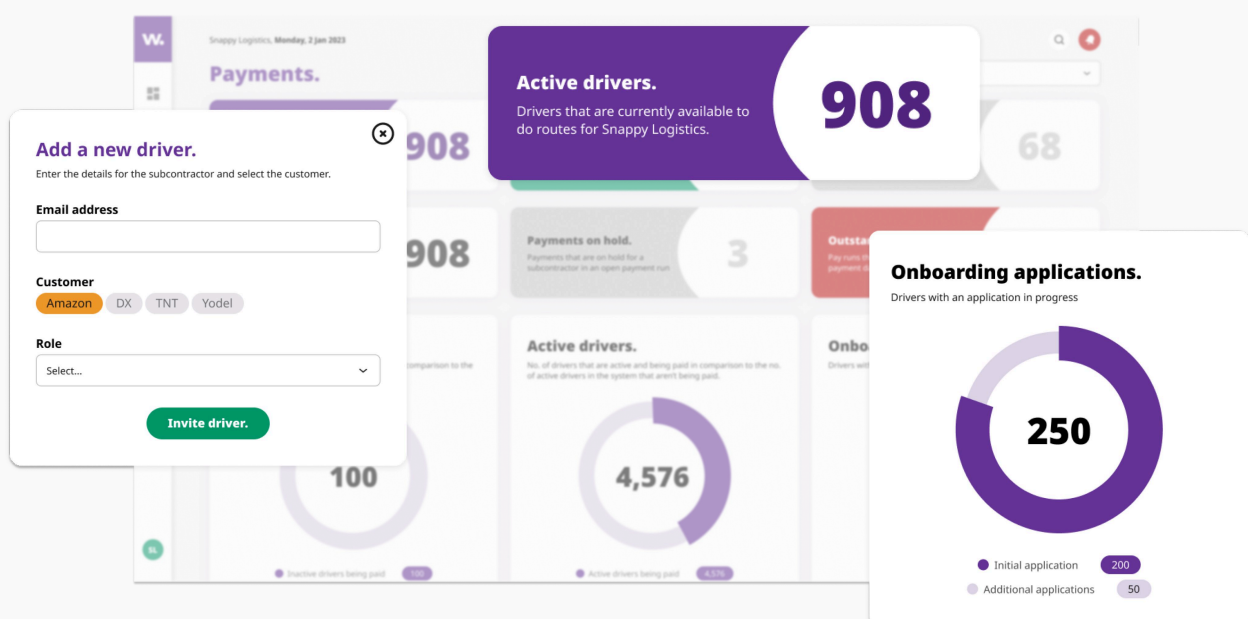

How does Beamin' work?

Beamin' introduces drivers to the Flat Rate VAT scheme. The Flat Rate VAT scheme was set up by the HMRC, to simplify VAT for small companies and self-employed courier drivers. This means drivers can charge VAT at the usual 20% and pay a lower amount to HMRC. The remaining balance is for drivers to keep, this can help to pay off their taxes at the end of the year - it's what we call the Beamin' boost!

What's included?

- We'll manage drivers' tax affairs, registering them for self-employment, so there's one less thing to think about.
- We submit accurate, on-time self assessments to HMRC each year, taking the pain out of tax returns!
- Simplified expenses process, with one place to add receipts and upload invoices, anywhere, anytime.
- Access to a whole heap of great benefits, including invoice management, wellness services, exclusive discounts and more!

And, if they're eligible...

- VAT registration on the drivers' behalf, generating a VAT number and helping them put money aside in their VAT pot.
- We submit and file drivers' quarterly VAT return to HMRC.
